Additional Explanations

On 10.11.2023, SAHOL shares with TRY 150,000 nominal value were repurchased within a price range of TRY 56.90 – TRY 57.15 (weighted average TRY 57.04) per share on Istanbul Stock Exchange by Sabancı Holding, pursuant to share buyback transactions initiated with the resolution of the Board of Directors of Sabancı Holding dated 09.11.2021.

As of 10.11.2023, total nominal value of repurchased shares have become TRY 4,850,000 which represents 0.2377% of the share capital, following the transactions.
